## 2009-10 Season Locker Revocable License

### COMPLETE THE FRONT OF THIS FORM AND RETURN WITH YOUR PAYMENT.

By acceptance and use of a Season Locker, you, as a Season Locker Licensee, make the following agreements, acknowledgments and give the following consent:

1. I acknowledge that I assume all risks of loss, damage, theft or vandalism and Squaw Valley Ski Corporation (SVSC) shall not in any way be liable for the protection or preservation of the contents of the Season Locker(s);
2. I give my consent to SVSC in the event of an emergency and in the event that SVSC is required to do so, to open the Season Locker(s) assigned to me for use. I acknowledge that insurance for locker contents is my sole responsibility, and further that I agree to be personally responsible to and agree to indemnify and hold harmless SVSC from any claim made by any person I permit to use the locker(s) assigned to me for use should their property be removed from the locker(s) for any reason, including but not limited to theft or vandalism;
3. I acknowledge that I may not structurally modify the locker(s) without the consent of SVSC; and that any damage to the locker(s) will be cause to revoke this license;
4. I acknowledge I will abide by the **rules and regulations established from time to time** by SVSC for persons using the Locker Room and/or **Preferred Parking Pass**. Passes remain the property of SVSC and can be confiscated by SVSC for misuse or abuse. Lost or stolen Parking Passes: I understand I must notify the Special Ticket Office and it may be replaced for a \$80 charge.
5. I acknowledge that I will be billed for the use of the Season Locker(s) each year and if payment for such use is not received by the DUE DATE my right to use the locker(s) will terminate, and that should the contents and the lock(s) not be removed from the locker(s) upon termination of my right to use the locker(s), SVSC may open the locker(s), remove the contents and assess a storage fee. Further, if the contents are not claimed, SVSC may dispose of the contents as provided by law.
6. I acknowledge that this Revocable License is non-transferable, non-creditable, and non-refundable for any reason. I further acknowledge that this License Agreement is terminable at the will of SVSC if all rules and regulations are not followed. SUBLEASING OR ASSIGNMENT OF LOCKER SPACE IS NOT ALLOWED UNDER ANY CIRCUMSTANCE. ASSIGNMENT OR SUBLEASING OF LOCKER SPACE SHALL CONSTITUTE AN ACT OF DEFAULT ON THE PART OF THE LICENSEE, AND SHALL BE GROUNDS FOR TERMINATION OF THIS AGREEMENT WITHOUT MONETARY OR OTHER COMPENSATION TO LICENSEE. **AUTHORIZED Locker users are either IMMEDIATE family (father, mother, children) OR Locker Holder and ONE OTHER INDIVIDUAL ONLY.** Guests are welcome **ONLY WHEN ACCOMPANIED BY THE ADULT LOCKER HOLDER.** Daily guest passes will be available at the desk and must be shown on request to Locker Room Attendant. Please inform your family members or the "other" user of this policy. Locker Holder agrees to comply with parking management signs posted and directions by SVSC personnel.
7. Licensee agrees to keep and maintain a lock on the season locker assigned to him/her at all times during the ski season. Failure to do so may result in a revocation of this license.
8. The Locker Room is open during scheduled hours only for access and will not be opened after posted hours **except by Security to obtain skis for night skiing and return them afterwards:**

Monday - Thursday	8:00 am - 5:00 pm
Friday	9:00 pm (unless there is no night skiing, close at 5:00 pm)
Saturday	7:30 am - 9:00 pm (unless no night skiing, close at 6:00 pm)
Sunday/Holiday Periods	7:30 am - 5:00 pm
9. The Locker Room will be open as long as lifts are in operation for the 2009-10 winter ski season.
